**DRINKS/SODA & WATER:** Vendors are NOT allowed to sell or give-away any soft drinks and/or water. All soft drinks and water will be sold ONLY by NACIP throughout the park.

**ELECTRICITY:** Electricity will NOT be available for Arts & Crafts booths.

**VENDOR REQUIREMENTS: PAYMENT:** Credit Card or Cash payments ONLY. NO PERSONAL CHECKS OR MONEY ORDERS WILL BE ACCEPTED!! NO REFUNDS WILL BE GIVEN FOR ANY REASON.

**A) UTAH STATE TAX COMMISSION (801-297-6303):**

Any vendors owing sales tax from this event for prior years will NOT be allowed to open until this is paid. A Temporary Tax ID is mandatory for all vendors (this is NOT your business Sales Tax ID). The USTC will be at the event around 10:00 AM on July 25th to issue temporary tax IDs in case you did not have time to contact them prior to the event. You must have a Temporary Tax ID before opening.

**B) ARTS & CRAFTS:**

This event is designed to promote Native American/Indian Arts & Crafts and to benefit the Native American/Indian people; however NACIP has invited all artists to participate as long as the artwork they display are of quality and promote the heritage of the Utah residents. We recommend the artwork/crafts compliment the Native American Celebration.

**C) VENDORS RESPONSIBILITY:**

- A. Conduct themselves in a professional manner.
- B. Keeping individual area clean.
- C. Supervision of children at all times for safety precautions.
- D. Setting up and vacating premises in a timely manner.
- E. Collecting and sending in Utah State Sales tax.
- F. No Vehicles can be driven on grass area without receiving permission from NACIP. No vehicle can be parked on grass next to the booth during the event.
